## **SERVICE AGREEMENT**

### **A. THE CLIENT AGREES:**

1. To comply with all provisions of the Fair Credit Reporting Act (15 USC 1681 et seq.), the Federal Driver Privacy Protection Act along with any other applicable federal, state and local laws, acts, regulations or ordinances governing the use and distribution of data furnished by Sure-Hire.
2. That before taking adverse action that is based in whole or in part on information received from Sure-Hire, Client will provide the Consumer to whom the information relates, the opportunity to dispute the adverse information consistent with practices outlined in the Fair Credit Reporting Act and any all other federal, state and local laws.
3. To pay Sure-Hire the full amount of charges incurred for services requested on or before the 25<sup>th</sup> day of the month following the month in which services were rendered. This will be according to rates agreed upon in a separate Price Agreement or rates stated on the current price list. Past due amounts shall accrue interest at the rate of 1.5% per month. If collection efforts are required, Client shall pay all costs of collection including collection agency fees and attorney fees.

### **B. SURE-HIRE AGREES:**

1. To comply with all provisions of the Fair Credit Reporting Act (15 USC 1681 et seq.), the Federal Driver Privacy Protection Act along with any other applicable federal, state and local laws, acts, regulations or ordinances governing the use and distribution of data.
2. To conduct research and services available requested by client in a timely manner consistent with standard business practices; however, results may be delayed on occasion due to slow information sources, unusual circumstances, or other reasons beyond the control of Sure-Hire.
3. To provide written documentation of the services requested upon completion.
4. To maintain documentation of the services completed minimum of two (2) years.
5. To provide individual itemized billing on a monthly basis.

Either party may cancel this Agreement at any time upon at least 30 days prior notice. However, with just cause, such as delinquency or violation of the terms of this Agreement or other legal requirements, Sure-Hire may discontinue service to Client and cancel this Agreement without notice.
3. This Agreement is the full and complete Agreement and is not to be altered or varied by any verbal promises, statements, or representations not expressed herein.
4. Any disputes and /or claims arising from this Agreement shall be Governed by and enforced in accordance with the laws of the State of Florida. Each party agrees that Sarasota County, Florida, shall be the exclusive, proper and convenient venue for any legal proceeding in state court, and the Middle District of Florida for Federal Court.
